FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION

The Four-to-Six Month Beginner Puppy competition shall be for dogs that are four months of age and under six months on the day of the event.

Classes will not be divided by sex in this competition.

AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Ch. 3, Sec. 1 of the Rules Applying to Dog Shows A Foreign born dog may enter this class if they are registered in the country of origin. FSS Number of FSS Registered litter number will be required for Miscellaneous and FSS Breed Entries.

All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol. •

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler.

Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the

show or any show during the cluster/weekend.

Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition

No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed Dealing with Misconduct will be applicable to any person and dog entered at this competition.

All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.

Eligible dogs will be identified by an asterisk in the steward's book and the catalog. Dogs must be handled throughout the breed level competi- tion for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in this competition.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be the Owner-Handled Best of Breed.
- If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner- Handled Best of Breed.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog and Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the oppo- site sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed including Winners Dog or Winners Bitch as the Best of Breed for the AKC National Owner-Handled Series.
- *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distrib- uted rate cards, or otherwise advertise or presented them- selves as handling dogs for pay within the last five years.
- ** A current assistant is defined as anyone employed by a profes- sional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.
